Lake County is home to 700,000+ highly educated residents, more than 30,100 acres of forest preserves and trails, miles of Lake Michigan beaches, world-class healthcare systems, top-rated schools, and over 30,000 thriving businesses. With eleven Fortune 500 company headquarters, 85 percent of Chicagoland's pharmaceutical manufacturing jobs, an advanced manufacturing and distribution center, and a diverse blend of thriving commercial centers and rural retreats, Lake County has a distinct economic identity that allows it to stand apart from others in the region.

Over the course of 2014, we were pleased to see Lake County's economy continue to improve. A number of large projects with significant associated capital investment were announced throughout the county, the unemployment rate fell by 3.5 percent between January and December, and a total of 9,247 jobs were created.

Lake County Partners contributed to this success by working to fulfill many of the actions recommended by the Comprehensive Economic Development Strategy related to workforce development, marketing/public outreach, and coordination. To ensure that Lake County remains a prosperous and attractive location for business, a 5-year Comprehensive Economic Development Strategy (CEDS) was approved in 2013 with the aim of increasing employment opportunities, and improving the quality of life. The CEDS provides guidelines for Lake County Partners' economic development initiatives, and it was prepared with the diverse input and assistance of private and public stakeholders.

Since its inception, the CEDS has served as a blueprint for Lake County Partners, guiding the organization's day-to-day activities in support of its stated long-term goals. Lake County Partners' core functions are closely tied to the CEDS implementation strategy, which emphasizes three overarching categories:

Job Creation

Recommended efforts within the "Job Creation" umbrella include aligning job training programs with projected industry growth, and strengthening and expanding partnerships with existing and new businesses at a variety of scales.

Marketing & Outreach

The CEDS calls on Lake County Partners to build on and expand its branding and marketing program with the goals of attracting new business opportunities, educating stakeholders on the area's many positive attributes, and reinforcing Lake County's prominence as a business hub.

Organization & Coordination

The CEDS directs Lake County Partners to strategically serve as a primary point of contact for economic development activities by consistently engaging investors and stakeholders.

Target **Industries**

Based on outreach and in-depth data collection conducted during the development of the CEDS, five targeted industries were identified as a focus of these efforts:

Bio Pharma: this sector accounts for over 6.3 percent of Lake County's employees, all of whom are highly skilled and educated

Medical Instrument and Precision Machinery & Tooling: this sector represents 2.4 percent of the businesses in Lake County and provides economic support to many industries, including the pharmaceutical and healthcare industries

Healthcare: this sector represents a strong network of major hospitals, outpatient clinics and services that collectively employ 8 percent of Lake County workers

Professional/Technology Services:

this sector is vast and includes corporate operations, advisory and consulting services, general employment, and business support services, as well as a number of robust subsectors

Arts, Culture & Entertainment: this sector is addressed in the CEDS because of its incredible importance to the overall quality of life in Lake County

The remainder of this report details the deliberate, programmatic steps that Lake County Partners took in 2014 to support the overarching goals of the CEDS and its target industries.

2014 Economic Development HIGHLIGHTS

Our more than 30,000 thriving businesses benefit from a number of attributes that result in a better overall quality of life for employers and employees, which is why Lake County businesses had such a successful year, as evidenced in the news from 2014:

There were 33 Fortune 500 company

headquarters in the state of Illinois, and 11 of those were located in Lake County—four more than in the City of Chicago.

Inc. Magazine released its "5000 List,"

recognizing thirteen Lake Countyheadquartered businesses among the top 5,000 fastest growing private companies in America.

Lincolnshire-based Zebra Technologies

solidified its position as a market leader by acquiring the Enterprise business of Motorola Solutions to provide advanced asset tracking solutions.

IDI Gazeley announced plans to invest

\$25 million to develop a 454,276 sq. ft. speculative facility in Antioch to provide office, warehouse and manufacturing space.

Northwestern Lake Forest Hospital

broke ground on a new \$378 million campus in Lake Forest.

Mundelein-based Medline announced

plans to add 200 jobs in Lake County and spend \$60 million expanding operations statewide.

HydraForce signed a lease for a

142,000 sq. ft. warehouse in Vernon Hills to establish a manufacturing hub for valves and machine control devices with the expectation that the company will hire at least 200 additional people within the next five years.

The College of Lake County awarded

a \$24 million contract for the construction of a new science building on its Grayslake campus to house classrooms and labs for programs in engineering, lasers, photonics, optics, chemistry, anatomy, and physiology.

The City of Waukegan annexed a

225-acre parcel for a proposed \$150 million business park to include new infrastructure and an industrial distribution and warehouse space.

Advocate Condell Medical Center

announced plans to build a state-ofthe-art outpatient center in Libertyville.

Highland Park Hospital is investing

\$74 million to upgrade facilities and offer advanced maternal care and surgical and radiology services in Highland Park.

Lake County government retained its

AAA bond rating, significantly reducing the long-term risk for both businesses and residents and distinguishing the County from others in the region with significantly lower ratings.

The Lake County Forest Preserve

District purchased the final piece of the Des Plaines River Trail in Lincolnshire to provide continuous trail access from Russell Road in Wadsworth to Lake Cook Road, where it will meet up with the Cook County Forest Preserves trail system.

MARKETING LAKE COUNTY

One of the cornerstones of the Comprehensive Economic Development Strategy is marketing and outreach. Key priorities stemming from this have included maintaining a dynamic website, providing informative and timely newsletters, publishing a new site selection brochure, remaining visible in local and national publications, and increasing the organization's presence and interaction on social media platforms.

In 2014, the "Lake County Promise" theme was carefully integrated into all marketing efforts and strategically woven throughout Lake County Partners' ongoing public outreach. To support the Lake County Promise campaign, we made a number of exciting improvements to our website to enable site-responsiveness, add additional information of interest to the business community, provide a central location for testimonials regarding the Lake County Promise, and integrate an interactive map with important county features.

Lake County Partners also developed a targeted Lake County Promise-based media strategy which included:

- On-going themed social media posts on Facebook, Twitter, and LinkedIn
- A feature article and advertisement in the Daily Herald Business Ledger
- An in-depth 4-month digital media campaign with Crain's Chicago Business wherein we showcased local industry leaders who contribute to the success of our businesses
- The development of a video featuring interviews with local industry leaders and their personal thoughts on the Lake County Promise

LAKE COUNTY LIFE INITIATIVE

Lake County Partners is one of many important county stakeholder groups that craft a message to relay information about Lake County. This year, in recognition of the need to unify themes that speak to all audiences, we partnered with key agencies including Lake County, the Lake County Forest Preserves District, the Lake County Health Department and Community Health Center, the Lake County Stormwater Management Commission, and Visit Lake County to focus on the facts that express the county's extraordinary attributes.

The result of this unique ongoing collaboration is Lake County Life—a countywide initiative that underscores the quality of life afforded to everyone who works, lives, and plays in Lake County. To support the effort, these partners worked over the course of 2014 to create a Lake County Life website with important county statistics and an accompanying video. Moving into 2015, Lake County will manage and oversee this important resource and Lake County Partners will continue to assist with advancing and promoting its message.

REGIONAL ECONOMIC DEVELOPMENT COLLABORATION

In 2013, the elected leadership of the seven counties of Northeast Illinois and the City of Chicago began to explore opportunities to collaborate and strengthen the regional economy. These discussions resulted in the establishment of a "Growing Our Regional Economy" forum series that extended through 2014. Outcomes from these meetings included the Chicago Metro Metal Consortium, the Metro Chicago Exports Initiative, and the streamlining of truck permitting in the region.

The Chicago Metro Metal Consortium (CMMC) represents an unprecedented collaboration of more than 60 partners who joined together to secure one of just 12 nationwide "Manufacturing Community" designations awarded by the U.S. Commerce Department through the Investing in Manufacturing Communities Partnership (IMCP)—an initiative intended to support job creation and accelerate growth in the manufacturing sector. Through IMCP, 11 federal agencies and programs with over \$1.3 billion in

federal economic development assistance will coordinate efforts to support the strategies developed by each of the 12 designated communities.

The Chicago metropolitan region is one of the nation's leading manufacturing centers and transportation supply networks, and metals manufacturers are an important local economic driver. CMMC will capitalize on these strengths with strategic actions aimed at building a world-class cluster for metal fabrication.

Building on this momentum, the Metro Chicago Exports Initiative will seek to increase exports from small- and medium-sized enterprises to meet rising demand in emerging markets by creating targeted pipelines, strengthening the network and coordination of services, and reducing the costs to these businesses.



Enhanced Business Outreach & Workforce Development Services

Building on the Comprehensive Economic Development
Strategy's emphasis on job creation, Lake County Partners
initiated a new, strategically targeted program of outreach to
local businesses in 2014. As part of this program, Lake County
Partners entered into a groundbreaking partnership with the
Lake County Workforce Department and Workforce Investment
Board. By coordinating and unifying our business outreach
efforts, we have worked with these stakeholders to:

- Gather improved intelligence on the needs of the Lake County business community, and use the information to develop multi-pronged tactics to address these existing needs
- Address a broader array of business challenges, with special emphasis on the skills gap and an aging workforce
- Ensure a wider reach for a key strategic asset—the Lake County labor force
- Streamline the communication path between business and government and more efficiently use our joint resources

Based on our initial efforts to understand the opportunities for and challenges to growth over the next three to five years, three over-arching themes have arisen:

Expansion: The business climate has improved, and sales have increased enough that many companies need increased production capacity. Many are also taking this opportunity to align production, warehousing, and distribution.

Workforce: With that business growth, there is an increased need for additional skilled employees, and the training of incumbent workers. There are many existing programs that can greatly benefit Lake County businesses, and Lake County Partners can expand awareness of these programs, and connect businesses where appropriate.

Services: Businesses are interested in learning more about regional, county, or municipal services, such as transportation and permitting, that can impact local operations.

In 2015, Lake County Partners will continue to lay the groundwork to address these needs and ensure that local businesses in the targeted industries of Bio Pharma, Medical Instrument and Precision Machinery and Tooling, Healthcare, Professional/Technology Services, and Arts, Culture, and Entertainment continue to have access to the resources that they need to grow and prosper.

Leadership Lake County

The Leadership Lake County initiative is focused on ensuring that County assets are appropriately leveraged to attract young professionals (aged 20-39) so that local employers can attract this talent pool to achieve long-term organizational success. In 2014, a Leadership Lake County Steering Committee was formed to ensure that the initiative appropriately balances the perspectives and contributions of millennials, local communities, and Lake County businesses.

In 2015, the Steering Committee will continue its work to fulfill the goals of the initiative by forming a baseline understanding of the existing conditions, programs, organizations, and resources that may support the objectives of Leadership Lake County. To accomplish this, the Steering Committee will embark on focus-group discussions and surveys with important stakeholders to determine long-term needs, and focus the Leadership Lake County initiative accordingly.

Municipal Economic Development Advisory Group



Lake County Partners will also continue its annual practice of hosting a booth at the International Council of Shopping Centers (ICSC) Annual Deal Making Show in Chicago to provide participating Lake County municipalities with a venue in which to connect with owners, developers, retailers, brokers, lenders, municipalities, property asset managers, and product/service providers.


