LCP IMPACT 2019-2020

The economic development projects that LCP has supported over the last two years have led to: 2,770 new jobs and 1,478 retained jobs for a total of 4,248 jobs in Lake County. These projects have led to more than \$290M in direct capital investments in Lake County, which doesn't include the wages paid to their workforce, or the indirect or induced impacts of these investments.

RISING TO THE OCCASION

Life sciences and advanced manufacturing boomed with an increased demand for products and services related to packaging, personal protective equipment, testing and healthcare.

INNOVATION PARK LAKE COUNTY

The cutting-edge campus celebrated a string of big wins as high-profile life science and technology leaders—including AveXis, Medline, Valent Biosciences, EVBox and Intermatic—moved in and looked to grow.

BIG BUSINESS

Industry leaders like AbbVie, Abbott and Pfizer captivated the world, leading the fight against COVID-19 with the development and manufacture of groundbreaking tests and treatments.

CORNERSTONE

Work continued on this massive development from Alter, in Grayslake, where Medline Industries broke ground on a 1.4 million sq. ft. medical-grade distribution center that will be the largest in the world.

FISCHER PAPER PRODUCTS

This third-generation food packaging manufacturer celebrated the grand opening of its new 162,000 sq. ft. headquarters in Antioch—a development that will result in an initial 30 new jobs.

PHARMA LOGISTICS

The pharmaceutical distributor opened a new 127,000 sq. ft. facility in Libertyville to house corporate office space and fulfillment center and build on its growth in Lake County.

HORIZON THERAPEUTICS

The company announced its purchase and development of the 70-acre former Takeda corporate campus in Deerfield, earned FDA approval for its new TEPEZZA medication that went on to win the Chicago Innovation Award, and signed on to support Helix 51—Rosalind Franklin University's bioscience incubator that provides a landing zone for national and international bioscience companies in the City of North Chicago.

BUILDING FOR BUSINESS

Speculative construction surged, confirming confidence in the local market and setting the stage for a vibrant future.

ROUTE 60 LOGISTICS CENTER

Venture One broke ground on its new 200,000 sq. ft. facility in Mundelein, creating an in-demand, multi-tenant industrial space.

BRIDGE POINT NORTH

Bridge Development
Partners reached
agreement with logistics
company Visual Pak
to lease 189,000 sq.
ft. in its Waukegan
development—one of four
buildings in the project's
third phase, adding
919,281 sq. ft. to the 225acre campus.

SOUTH LAKE INDUSTRIAL CENTER

Panattoni Development's new \$100 million industrial center in Vernon Hills will include four new buildings totaling 904,000 sq. ft. and designed to accommodate distribution, e-commerce, light manufacturing, headquarters and offices.

LIBERTYVILLE 45 CORPORATE CENTER

Midwest Industrial Funds invested in the construction of a two-building speculative corporate center totaling nearly 335,000 sq. ft. that will provide state-of-the-art space for life science and advanced manufacturing companies looking to grow.

HAWTHORN MALL

The \$250 million makeover in Vernon Hills moved forward, redeveloping the space for new restaurants, retail, luxury apartments and a \$6.2 million overhaul of the interior center court.


